We engaged in a lengthy discussion about Chromebooks at Clifford. Ms. Cody explained in more detail how they are used in her 4<sup>th</sup> grade classroom expressing that they were no longer a supplemental device used in teaching, but essential to learning. Chromebooks in the upper grades have become the defacto textbooks. It was also discussed that there is a lot of curriculum the kids are not accessing because we don't have a 1-1 ratio of Chromebooks in the classroom. All of the annual testing that goes on is online and Clifford is judged based on the results of this testing. The possibility of starting a campaign to talk to the Board about supporting a 1-1 Chromebook ratio was discussed.

The budget for next year from the school district is still very much in flux. The subject of becoming a Title 1 school was brought up since 39.5% of students at Clifford qualify for free or reduced lunch. The pros and cons of such a label were discussed. The main motivation would be to bring in an additional \$60,000 from the state. The preliminary budget was presented but will have edits at the May meeting for approval by PTO.
